PAYMENT OF MANAGEMENT FEE AND PERFORMANCE FEE BY WAY OF ISSUE OF UNITS IN KEPPEL INFRASTRUCTURE TRUST

Keppel Infrastructure Fund Management Pte. Ltd. ("KIFM" or "KIT Trustee-Manager"), as trustee-manager of Keppel Infrastructure Trust ("KIT"), wishes to announce that 522,217 units ("Management Fee and Performance Fee Units") in KIT ("Units") have been issued today at a price of \$\$0.5430 per Unit as payment of 4.8% of the aggregate of the management fee and performance fee due to the KIT Trustee-Manager for the period from 1 October 2019 to 31 December 2019.

The issue price per Management Fee and Performance Fee Unit is the volume weighted average price for a Unit for all trades done on the Singapore Exchange Securities Trading Limited (the "SGX-ST") in the ordinary course of trading on the SGX-ST for the last five trading days (that is, the last five full market days when the Units are traded on the SGX-ST) of the quarter ended 31 December 2019.

The payment of the management fee and performance fee and the manner of such payment are provided for in the trust deed dated 5 January 2007, as amended, supplemented or restated from time to time, constituting KIT (the "**Trust Deed**"). It is provided in the Trust Deed that the KIT Trustee-Manager is entitled to receive its management fee and performance fee in a combination of Units and cash in such proportions as it may elect. For the period from 1 October 2019 to 31 December 2019, the KIT Trustee-Manager has elected to receive:

- (i) 4.8% of its management fee and performance fee in the form of Units; and
- (ii) 95.2% of its management fee and performance fee in cash.

Following the issuance of the Management Fee and Performance Fee Units, the KIT Trustee-Manager's unitholding in KIT is 522,217 Units, representing approximately 0.01% of the total number of issued Units in KIT. The total number of issued Units in KIT as at the date of this announcement is 4,994,913,286.
