The KIT Trustee-Manager is pleased to announce that the closing deliverables were completed on 9 September 2022 with the parties agreeing that the effective date of Initial Completion had taken place on 8 September 2022. The purchase price of JVCo’s interest in the Initial Portfolio is approximately €58.7 million (S\$85.7 million)¹.
