LOAN FACILITIES OBTAINED BY KEPPEL DC REIT GROUP

The Board of Directors of Keppel DC REIT Management Pte. Ltd., as manager of Keppel DC REIT (the “**Manager**”), wishes to announce that a wholly-owned subsidiary of Keppel DC REIT, Keppel DC REIT Fin. Company Pte. Ltd. (the “**Borrower**”), has obtained the Loan Facilities (as defined below) guaranteed by Perpetual (Asia) Limited (in its capacity as trustee of Keppel DC REIT) pursuant to two facility agreements, each dated 28 March 2025 (the “**Facility Agreements**”).

There are conditions of the Loan Facilities in the Facility Agreements which make reference to a change in the Manager or the effective shareholding therein. A description of the relevant conditions is set out below:

Loan Facilities	Relevant Conditions
S\$150,000,000 revolving credit facility	Under the terms and conditions of each of the Facility Agreements, the Borrower will be required to pay all outstanding loans together with accrued interest and all other moneys owing under or pursuant to each of the Loan Facilities within 10 business days in the event that the Manager ceases to be a subsidiary (whether directly or indirectly) of Keppel Ltd. (each, a “ Mandatory Prepayment Event ”).
S\$150,000,000 revolving green credit facility	

Assuming (i) the occurrence of the Mandatory Prepayment Event, and (ii) that such occurrence would cause a cross default under other borrowings of the Keppel DC REIT group, the aggregate level of utilised and unutilised facilities that may be affected is, as at the date of this announcement, approximately S\$2,578.0 million (excluding interest and fees).

As at the date of this announcement, each of the Mandatory Prepayment Events has not occurred.
