The following entities (collectively, "Relevant Entities") acquired an aggregate of 356,758,432 new Units in the Preferential Offering, as follows:

- (i) Keppel acquired an aggregate of 343,941,556 new Units.
- (ii) Fullerton acquired 719,509 new Units.
- (iii) DBS Bank Ltd. ("DBS Bank") acquired 12,097,367 new Units.

Temasek's deemed interest in Units arises through Keppel, DBSH and Fullerton.
